#### **Minutes**

#### **DRED** update

### **Budget Update**

- -Mike met with selectmen last week and presented the same budget. There should be about \$1,100 left. This will help when income from the timber cuts stop. Will use between \$800-900 towards septic review committee and secretarial work.
  - Mike will talk to Rob as the FAC set their budget two weeks ago.
- Mike mentioned there is grant money available for the septic review committee. Paul asked if we have a grant writer. Barry Keith might be able to do it.

#### **Intent to Cut Applications**

Two intent to cut applications were reviewed. App # 15-165-10-T was unanimously approved. App #15-165-09-T, Map 12, Lot 5. The board would like to see: Safe wetlands practice, Silt barriers, Safe brook crossing and culverts. Mike will speak with FAC and Selectmen.

#### **Septic Review Sub-Committee**

- Paul will take 4 members and split up the waterways to be reviewed.

Check future meeting minutes for any amendments or changes to these minutes.

### **Subdivision**

There was discussion about subdivision regulations as they relate to septic and water. Does there need to be community septic and water if each lot is under ½ acre or if the subdivision continues as a condominium project. There are two other condominium communities that had to install community water and septic and if this project doesnøt, there is a concern for a possible law suit. Mike will ask the selectmen if they are getting legal advice about this.

### Other

Alice said that Green Mountain Conservation will be sending out a brochure on best management practices to 600 people on Ossipee Lake. Alice will bring in a brochure to see if we can put it on the website.

Paul mentioned that the town of Meredith arranged for homeowners to bring in a water sample. The town sent them out at a group cost. This could be something to look into for Freedom to offer as well.
