Minutes

Scrub Oak Scramblers (SOS) is in the process of obtaining new gates for the town forest. Five new locks are needed. A motion was made by Rob, seconded by Alice, to approve the purchase of 5 new locks for gates in the town forest. All were in favor. Rob further explained that the Jackman Ridge Rd. gate has been left open. Paul or Rob will go to the Board of Selectman (BOS) asking them to send out an interoffice memo, to all town department heads, asking that the town forest gates be left locked if found that way.
