

**Minutes of Selectmen's Meeting, Town of Freedom, NH 03836
Monday, July 2, 2018**

Meeting was called to order at 6:30pm manifests were signed and mail was reviewed.

Public comment: Karl Bloomquist and Dorothy Read addressed the board. They are concerned about a section on the side of Loon Lake Road that has deep water and would like the Selectmen to consider putting guard rails in. Had questions about cutting trees on waterfront. Les referred them to Don Harris for zoning regulations. There are beavers living in the banks of the inlet causing the issue. The Selectmen will ask Road Agent Scott Brooks to look into removing the beaver.

Rob Cunio reviewed calls from the prior week. 43 calls. Engine 2 is having an electrical issue but is being addressed. Rob requested a nonpublic session under RSA 91-A3:II(c).

Justin Brooks, Transfer Station manager reported that the compactor is not working properly. Would like to begin researching prices to be ready for the budget cycle.
