Rob informed the Board that the Freedom Conservation Commission (FCC) approved the extension of the 2013 Town Forest Cut as well as thinning out of the 20 acre control burn plot.

Signs will be put out during mud season then taken down when the gates reopen.

Rob has sent a letter to Danforth Bay Campground (which he read to the board) asking them to keep their golf carts on the path so as not to ruin a log landing of clover.
