# **Milfoil Control Update**

The grant for 2016 has been completed. NHDES has been out to survey the town water bodies and found growth in Liguori Cove and the Marina. Roberta McCarthy told the board that Liguori Cove has substantially grown. Jim has been working with Effingham to help them address milfoil in the shallow cove near the dam as well as help in preparing data for them to present to Effingham Board of Selectmen asking for funds. The \$8,000.00 from the town milfoil account has been used and funding needs to now come from the gift account.

#### **Lake Host Program Update**

The Lake Host Program for 2015 was completed on Labor Day Weekend. A motion was made by Gerard, seconded by Ned, to draft a letter from the Freedom Board of Selectmen to Lake Host Nancy Johnson thanking her for a job well done. All were in favor. Nancy is enthusiastic about coming back next year. There was a motion by Gerard, seconded by Ned, to draft a letter from the Freedom Board of Selectmen to the Marina thanking them for their support. All were in favor.

The board went over the 2015 Lake Host Program Payroll Grant Status as of September 1, 2015.

Jim participated in a Thank-a-thon to acknowledge the efforts to all lake hosts. This was very well received. Jim gave a big thank-you to Ned and Bill for volunteering.

Some suggestions for next year were:

- increase the number of inspection locations (Loon Lake, Danforth Bay etc.)
- increase the number of volunteers
- publicize work and get more involvement for local people

Marcia Santner asked if bumper stickers could be provided to the public thereby giving publicity to the milfoil cause. The board thought this was a good idea.

Bruce asked if a link could be set up on local Lake Associations Website, linking them to the state milfoil website. He will do follow-up on this issue.

Jim will work with Karen to accrue any unused personnel money into next year.

Roberta McCarthy, Berry Bay Assoc., asked if any volunteers were needed to pick up floaters further stating she could get some if needed.
