### FAC Report – Rob Hatch

- FAC is working on scheduling a late winter work shop to schedule bird watch criteria.
- The 28 acre cut at Pequawket Gate has been completed.
- The Board of Selectmen asked the FAC to solicit bids for anything over \$1,000 as well as the town forester and get an endorsement from DES.
- Rob read a letter from DES stating they do not send endorsements but they are satisfied with work the present town forester is doing.
- New grant money is available to offset the work needed on the Jackman Trail. Rob will send information to Barry so he can pursue.
- Future projections for the Town Forest Maintenance Account make it viable through 2028. In 2014/2015 there will be cuts then go to a 5 year cut program which will reduce the budget by \$2,500 in the years with no cuts.

There was a motion by Mike, seconded by Alice, to accept the FAC Report. All were in favor.

### FAISC Report – Jim McElroy

An updated FAISC Report was passed out and explained. Four (4) quotes have been received for 2014 DASH & Herbicide Treatments. Jim should find out by the next meeting if any grant money is awarded to Freedom.

#### Ratify 2014 Budget Vote
