Mike commented that Oram asked him why the FAC did not allow/approve a horse drawn carriage ride through the forest for Old Home Week this year. Mike checked and found out the Old Home Week Committee was awarded money for the hike but chose to keep it and hopefully match it with next years money to celebrate the anniversary of the town forest. Mike forwarded the Old Home Week minutes on the subject to Oram.

Bill asked what Mr. Boyleøs reaction was to the pond on the airstrip where the fishing derby could be moved to and what he thought of not being able to cut down brush. Rob stated there was no reaction and Michael also has had a talk with Neal about the subject and heøs fine with whatever the outcome. Rob explained the need for an insurance certificate from the group holding the fishing derby in order to hold it in the town forest.

Paul commented that he went on the hike during Old Home Week that Rob conducted and thought it was spectacular. He was impressed with the condition of the forest and the amount of work that has gone into keeping it.

**Case #24-6-1-14 Paul and Elizabeth Pappas** 6 *Applicant seeks an appeal for a special exception under Article 3 Section 304.6.3.1 and a variance under Article 3 Table 304.5 of the Zoning Ordinance: To install stone wall, replace stones at beach, replace brick patio and add stepping stones all within the setbacks and requiring erosion control at 121 Haverhill Street.*

**Case #23-7-14 Mark and Susan Goldstein** 6 *Applicant seeks an appeal for a special exception under Article 3 Section 304.6.3.1 and a variance under Article 3 Table 304.2 of the Zoning Ordinance: To replace existing stone retaining wall including relocating, reorganizing and replacing stones and stairs within the setbacks and requiring erosion control at 28 Sunset Road.* 

### Board Concerns:

- Check the 10% Rule calculations
- Roof overhangs must be added into totals
- Is the space above garage going to be livable? If so, can septic handle the design?

**Case #27-13-14 Wayne M. Wenzel** 6 *Applicant seeks an appeal for a special exception under Article 3 Section 304.6.3.1 and a variance under Article 3 Table 304.5 of the Zoning Ordinance: To construct a garage within the shorefront setback requiring erosion control at 494 Pequawket Trail.* 

### Board Concerns:

- Follow best management practices for erosion control
- Is room above garage inhabitable? If so, can the current septic system handle the design?

There was a motion by Bill, seconded by Mike, to approve all concerns for ZBA Applications, Case Numbers 24-6-1-14, 23-7-14 and 27-13-14. All were in favor.

The board discussed the possibility of adding a line to the existing ZBA Application for Septic Design and asking applicants if their current septic system is going to handle the new designs. Mike is going to the next Planning Board meeting and will bring up the subject.
