Septic Review Sub-Committee

Elie presented to the committee a draft spreadsheet containing basic information for the Round Pond area regarding septic systems. Name, address, map/lot and any information found regarding septic systems including construction and operation approval dates, number of bedrooms, flow rates and distance to shorefront. Elie asked if there are other categories this committee would like to see listed. Gaudette suggested differentiating actual number of bedroom versus number of approved bedrooms; Hatch suggested listing change of use. This information gathered will eventually be pulled together with Ossipee and Effingham. All towns around the lakes need to be involved.

ZBA Shorefront Application

Case # 32-31-15 Don E and Cheryl Harris Jr 6 Applicant seeks appeals for special exception under Article 3 Sections 304.6.5.2, 304.6.5.4 and 304.6.4; and variances under Article 3 Sections 310.1.5, 304.2 and 304.5: To remove existing cottage and construct house and garage within the setbacks exceeding the allowed 10% lot coverage; all requiring tree removal and erosion control within the shorefront at 45 East Danforth Road.

Recommendations:

- 1. No tree stumps to be removed below infiltration trench line.
- 2. Compare that septic approval bedroom number matched actual bedrooms
