#### **Minutes**

#### **Public Hearing**

The public hearing was a vote to put 3 amendments on the 2013 ballot.

### Amend Tables 304.1 – 304.4 of the Freedom Zoning Ordinance

Change the tables listing permitted and special exception uses to reflect the changes voted in 2012 that defined minor and major home occupations. õMinor home occupationö will be added as a permitted use. The special exception use now listed as õhome occupationö will change to õmajor home occupationö. These changes will be made in four (4) district tables:

304.1 Village Residential District

304.2 General Residential District

304.3 Rural Residential District

304.4 Residential/Light Commercial District

Board Comments: Peter stated that all board members have reviewed and discussed this change. Public Comments: none

There was a motion by Pam, seconded by Peter to accept the amended tables 304.1 ó 304.4 to add Minor Home Occupation as a permitted use and change õHome Occupationö as a õSpecial Exception Useö. All were in favor.

## Amend Appendix A District Boundaries of the Freedom Zoning Ordinance

Extend the Residential/Light Commercial District along Route 153 from its current end at Bennett Road to the Madison town line.

Board Comments: Peter stated that all board members have reviewed and discussed this change. Public Comment: Carol Foord wondered why this change was happening and was looking for background information. Anne gave Carol background information.

There was a motion by Peter, seconded by Pam to amend Appendix A to extend the Residential/Light Commercial District along route 153 from its current end at Bennett Rd to Madison town line. All were in favor.

### **Amend Article 18 Section 1802 Definition of the Freedom Zoning Ordinance**

Bring the definition of Retail Store in Article 18 (Definitions) that says a retail store is a special exception use into conformance with the language of table 304.1 that allows retail stores as a permitted use.

Board Comments: Peter stated that all board members have reviewed and discussed this change. Public Comment: Carol Foord wanted the definition of õPersonal Servicesö. This definition could not be found and after some discussion she had no issues with this topic.

There was a motion by Peter, seconded by Janet to bring the definition of Retail Store in Article 18 (Definitions) that says a retail store is a special exception use into conformance with the language of table 304.1 that allows retail stores as a permitted use. All were in favor.
