Demolition Reporting: Guests Nadine Miller and Megan Rupnik were requested to attend our meeting for a first hand exchange of information regarding our group's work and future endeavors. The subject of demolition of properties was discussed: Present policy in Freedom. Should there be notification in advance? Is a permit required? There is no State Wide policy or regulation. Alan Fall will attend a Selectmen's meeting to further review this subject and desired action for the Heritage Commission.

Ms. Rupnik will visit again to find out more about the town and discuss a streamlined process for our own inventories and for surveying buildings and sites for State Historic Register.

Roller Shed: All scheduled work has been completed including placement of the siren (did not repair). Some discussion on how the siren was used and the remote control panel that is available. Will take this project off the active list.

Signs for School House Locations: Motion approved to add a sixth location (Shawtown) to those previously approved: Cushing Corner, Watson Hill, Scarboro, Farnsworth, and Mountain View. The signs will be brown and ordered from the State Prison System.

Snow Roller Replacement: No progress to report. Ken Wheeling who participates in activities at the Fryberg Fair display building is a good resource. Will take this project off the active list.

Why Did You Move to Freedom: Scott will be working on a program for a future Community Club dinner. He is looking for a variety of stories.

OHW Participation: Expect to continue participation in 2018 same as 2017.
