

**Selectmen's Meeting  
Wednesday, June 14, 2023**

Chairman Les Babb called the meeting to order at 8:00 a.m. Present were Selectmen Les Babb, Ernie Day and Melissa Florio, and Stacy Bolduc, Town Administrator, who recorded these minutes. This meeting was held at the Town Office.

Also, in attendance were: Rob Cunio, Gary Williams

Chief Rob Cunio came before the board to discuss the fire escape before they went into nonpublic. It was documented in the Bergeron Report done for the Town Office Committee that the fire escape is unsafe for egress. As fire chief he has to act on that report. Ernie asked what his recommendation is. Rob said you can't use the second floor. Les said does that just mean the Selectmen can't meet here and Gary and Sam can still work here. Rob said it has been deemed for multiple people. Stacy said that Sam or Gary could have two or three customers at any time. Rob said with STR we tell people they cannot use their second floor until you replace your windows for egress. The report is from last summer and this is the first Chief Cunio has seen it. The conversation came up because Gary and Chief Cunio need to inspect town buildings.

Ernie said it has not been decided if we are staying in this building and suggested getting a price on fixing/replacing the fire escape. The new fire escape will need to be covered. Gary Williams will call Jim Rines to see if he can recommend a structural engineer. Discussion ensued on where space available for Gary and Sam to relocate them. Sam will work downstairs and Gary will relocate to the Public Safety Building. The printer that is upstairs will go over to the Public Safety Building.

**Non-Public Session(s):**

Les received a complaint regarding the sign for Ducky Days on the Town owned land on Eaton Rd. Gary will call Kate Chaput and explain the sign needs to be taken down.

Hazardous Waste reimbursement was discussed for Wolfeboro. It was decided to reimburse the \$45.00.

All in favor, the motion passed. Les made a motion to resume public session at 9:40 AM. Ernie seconded. All in favor, the motion passed.***

There being no other business to come before the board. Les made a motion to adjourn at 9:45 a.m., motion seconded by Ernie; Motion passed 3-0-0.
