Town of Freedom Selectmen's Meeting Monday, March 17, 2025

Present: Selectmen Les Babb, Gary Williams and Stacy Bolduc, Admin. Assistant, who recorded the minutes. This meeting was held at the Town Office. Babb called the meeting to order at 6:30 p.m.

Review of Mail, Sign Manifests, Approval of Minutes

The accounts payable and payroll manifests and the red folder containing correspondence were reviewed.

There was a brief discussion on whether the petition warrant article could be amended. Stacy will check with DRA if the warrant article could be amended. Don thought it could be if the subject matter is not changed.

Department Head Updates

Transfer Station- Alan Libby reported everything is going well. Something will need to be done about the entrance.

Highway- Scott reported all is going well he just waiting for things to dry up. He asked the board if they have a plan for the relocation of the compactor. Alan Fall stated he will work with Scott on shooting some grades. The brush pile will also be relocated so there will be a clear view of the tin pile. The pile of rocks was briefly discussed.

Les said the dumpster Scott mentioned is for the fire that happened on Clover Lane and the Board made an exception to the road ban for this fire event. The highway department will escort the dumpster to the site.

Police- Rich updated the board that Chief Mullen has talked to surrounding towns about community service in leu of fines for young people.

Office- Stacy reported that she is still catching up on what did not get done because of preparation for the Town Meeting.

Fire- Rob reported for the past two weeks the following: one structure fire, propane leak at Calumet that happened today. In both cases no one was hurt. Rob thanked the Freedom PD for their support. Rob gave the board paperwork from GW Brooks for the dredging on Scarboro road. He recommends them based on similar work done in the past.

Public Comment:

Alan Fall wanted it on record how proud he is of Freedoms Fire and Police departments for their outstanding work done in both the fire on Clover Lane and the gas leak at Calumet. Les added he was very pleased with how the town meeting went and he was able to report the budget was under spent because

departments are very mindful of how they spend money. Alan Fall reported that he has made contact with Beth Miller and is ready to move forward with the design.

Rob reported that he witnessed an incident in the office where a resident made rude comments regarding office staff and that he spoke up to the resident stating that the comments are uncalled for and inappropriate over not getting an email regarding town meeting.

Alan made a motion to elect Les Chairman for the Selectboard, motion seconded by Gary; Motion passed unanimously.

Alan Fall made a motion to accept G.W. Brooks' bid for the fire pond dredging on Scarboro Road, motion seconded by Gary; Motion passed unanimously.

- The burn was briefly discussed, hopefully it will happen this year.
- The trim on the town office is from Bill Barrows for \$6,800.00. The purchasing policy states getting three informal prices under \$10,000. Alan Fall will reach out to both Jay Hounsell and Jason Earle for additional quotes.
- The rec department offer will be non-public. Stacy will redistribute the policy that other town have.
- The mini splits went out to bid. There are two bids. Discussion if there should be another one.

The purchasing policy was reviewed, and it was decided that a public discussion will be held next week regarding the dredging of the fire pond and the mini splits.
