Minutes

There was a motion by Bill, seconded by Ned, to approve the minutes of October 9, 2014 as amended. All were in favor.

Status of Milfoil Control Efforts

The last hand pulling efforts on the Danforth was conducted on October 9, 2014. Spending to date is:

- \$6,500 from budget line item
- \$6,469.50 from Milfoil Gift Account
- \$4,104.20 grant reimbursement to the town still pending
- \$639.81 administrative costs

Jim McElroy spoke at the Berry Bay Annual Meeting on October 11, 2014 as well as submitted a written article for the Ossipee Lake Alliance Newsletter. Jim met with the Freedom Board of Selectmen (BoS) to discuss the 2015 FAISC budget. The BoS would like to keep the same funding in 2015 as 2014. The Committee will increase funding efforts to the gift account. This will be revisited at the end of the year to see the status of the gift account and the possible need to increase the line item amount. There is the potential for higher grant funding next year because of the increase in boat registration. Jim will look at the spending analysis to check the donations for the past 3-4 years. There was a motion by Bill, seconded by Bruce, to accept the current status report. All were in favor.
